萬一當顏料印花製程中一定要使 4,4'-二胺基二苯甲烷(簡稱 MDA, 化學摘要號碼 101-77-9),那麼 4,4'-二胺基二苯甲烷就可能不是源於限制偶氮著色劑而是來自 於化學固色劑

中華民國標準 CNS 15205-1 L3267-1,會進一步將對 4-胺基偶氮苯繼續還原,而產 出非限制物質的苯胺和1,4-苯二胺。因此,當苯胺及/或1,4-苯二胺的分析結果是 有數值時,則依照標準 德國食品及日用品法 & 64 LFGB, BVL, B 82.02.9 對 4-胺基偶氮苯的有無再次確認。

偶氮的限制值,明訂於中華民國國家標準 CNS 15331 S2158 第 4.2.4 節 依據客戶的要求,隨機取樣進行混測測試,測試結果就是代表整體的結果。
